EGALITE - the European Group for Accreditation and Liaison of Blood-Tissues and Cells Establishments - is a 30-month project, which aims to promote the harmonization of practices among Collection Centers, Blood, Tissue and Cell Establishments, to encourage sustainability and collaboration among stakeholders, and the implementation of strategies to improve accessibility and sufficiency of SoHO (Substances of Human Origin) at the European level.




## **Key Goals of EGALITE**



The **outcomes** of EGALITE aim to support the activities performed in Member States with distinct technical capacities by developing and establishing:


- A European Accreditation Program as a means to achieve mutual recognition amongst SoHO organisations
- An efficient database of resources (Collection Centres, facilities, activities and innovative techniques, etc.) which will be used to design sufficiency plans and promote the collaboration among professionals and CAs, to ensure an adequate supply of Blood, Tissues and Cells (BTC) in the different MS
- Contingency plans to assist the responsible persons in the decision making process during a crisis
- A Technical Assistance Program to assist the implementation of good practices and optimization of activities in the different EU Member States

### **Key Expected Outcomes**

#### Establish EGALITE

Establishing EGALITE as a formal entity, will require the definition of a financial management model able to ensure sustainability, without pursuing financial profit.

EGALITE Partners will lead the discussion regarding the definition and adoption of practical procedures, rules and by-laws required, to ensure the appropriate representation of experts, transparency, and guarantee the long-term sustainability of projects outcomes.

#### **EU Accreditation Programme**

The implementation of an EU Accreditation Programme to promote equal access to SoHO within EU Member States, with the aim to be sustainable and recognized by all stakeholders at the EU level – same quality and safety for all donors and patients.

The EDQM Guides currently provide a comprehensive set of standards, which cover all SOHO activities, processing and distribution. These practices will be implemented as standards for accreditation, and WMDA, JACIE and EDQM's B-QM Programme, will be used as as a model to develop the common European accreditation standards.

The accreditation system will include: training programmes and certifications mechanisms for professionals and auditors.

#### **BTC** Database

A BTC Database will be produced to gather technical and practical information which will enable the active collaboration among peers.

The IT platform will provide the ability to share resources (donations, BTC, facilities) according to availability and clinical needs.

The new BTC database will be harmonized with the minimum dataset defined by the EDQM, and shall include additional information required for the definitions of sufficiency and contingency plans, namely:

- Include information related with the activities of the different SOHO Entities
- Information related with the facilities/clean rooms and technologies available
- Capacity to process BTC to third parties
- Level(s) of sufficiency
- ★ Status of Accreditation(s)
- any other necessary info deemed appropriate

#### **Contingency Plans**

EGALITE will define action plans which shall be activated in case of a crisis and according to the crisis scenario occurring.

The contingency plans will propose procedures to assist the responsible persons in the decision-making process during a crisis.

This deliverable will rely on the collaboration among accredited SoHO establishments in Europe. These plans foresee different scenarios which SoHO Entities are temporarily unable to perform their normal activities. The plans aim to:

- provide support for professionals, and optimize the use of all resources during a crisis
- will consider the possible exchange of donated SoHO, staff or BTC for transfusion/transplant
- will include the definition of (hemo- and bio) vigilance procedures which aim to oversight of the execution of the plans by the EGALITE
- define clinical recommendations/ procedures for donor evaluation and selection and patient care, based on collected data whenever possible

#### Technical Assistance Programme

The definition of the Technical Assistance Programme is inspired by the Technical Assistance and Information Exchange (TAEIX) instrument of the European Commission.

However, the EGALiTE Technical Assistance Programme will provide assistance to SoHO Entities, and Competent Authorities of any European Member State.

The activities proposed for the Technical Assistance Programme include:

- Workshops: EGALiTE experts to present specific areas of technical knowledge in workshops to a large number of beneficiary officials
- Expert missions: EGALiTE expert(s) to be sent to the beneficiary administration to provide in-depth advice on the transposition, implementation or enforcement of specific technical knowledge
- Study visits: Applicants to take part in a study visit to an accredited organisation

The Technical Assistance Programme will propose the mechanisms to fund and coordinate the participation of EGALiTE accredited experts in the activities requested by the different Member States.

Enhancing the capacity of SoHO Entities to respond rapidly and in a co-ordinated fashion to health threats


Provide contingency plans to be implemented by Health systems/ Public organisations in times of crises

Implement technical assistance for EU Member States in times of crises, to assist the implementation of best practices and optimisation of activities, and a mapping of SoHO resources

- Develop an efficient database with an overview on available resources
- Establish cross-sector consensus on training programmes

Achieve sustainability of EGALiTE outcomes, and implement pilot programmes allowing timely adjustments on deliverables

Overall, the aim is to develop and establish a quality programme, delivering significant benefits and utility – for citizens and health systems/organisations – on the provision of blood, tissues and cells.



# THE IMPACT



Sharing Resources at EU level is expected to be simplified

Member States will have the opportunity to easily request and obtain Technical Assistance

The primary aim is for SoHO Entities to develop the ability to react during crises and catastrophes, as a result of improved cooperation among involved stakeholders and the immediate adoption of the developed contingency plans



Competent Authorities, will be able to rely on an independent group of qualified European experts

## Project's Sustainability

The proposal foresees the creation of independent accreditation committees and the definition of the responsibilities, possible funding mechanisms and procedures associated with the future maintenance and management of EGALiTE outcomes and activities.

Extensive work is foreseen on implementing pilot actions at a national (Spain) and EU level.

A close collaboration with scientific societies and other accreditation programmes is envisaged to ensure the sustainability of the deliverables and outcomes by EGALiTE, and its integration and continuity following the project's completion.
