

The SoHO Coordination Board (SCB) - harmonize EU-wide implementation



Decide on

- ✓ Best practices for
 - supervisory functions
 - compensation conditions;
- ✓ Indicative criteria for critical SoHO and critical SoHO entities
- Decide on support for joint oversight activities;
- Coordination during emergencies

Provide input to COM for the **SoHO Platform**

SCB

Members: 2 per MS + 2 alternates

Co-chairing by Commission and MS

Secretariat: Commission

May invite observers and experts

Compendium on regulatory status; record of:

- Advices given by SCB on regulatory status
- National decisions on regulatory status



- 6. (Kind of) **NEW!** Regulatory questions




Sharing/engaging CAs in work + Possible EU funding for some tasks

New ECDC recommendations integrated in the next update of EDQM guidelines




Comprehensive guidelines on quality and safety per type of SoHO (blood, cornea, stem cells, ...) Regulation-proof versions of guidelines, in 2026

SANTE role - Mandatory EU Support



- a. SCB secretariat and co-chair facilitate cooperation other advisory bodies (Art. 72)
- b. Develop and host **SoHO platform** annual aggregated SoHO reports (with EDQM) (Art 31)
- **c. Funding** for collaborative work CA and professional societies focus on supply/donation/optimal use, and for technical guidelines updating (Art 72)
- d. Union **training for SoHO CAs** EU-27 / EEA / candidate countries, dissemination materials, exchange programmes, list of trained staff (Art 70)
- **e.** Commission controls of NCA/CA/delegated bodies (Art 71, not before 2028)
- f. Providing more clarity by adopting (6) Implementing Acts and (one) Delegated Act




Legal Acts SoHO regulation

- IA on SoHO platform DDL August 2025 (Art 74(4))
- DA on import DDL August 2027 (Art 47(4))
- IA on import DDL August 2027 (Art 48(7))
- IA on data sets for activity data DDL August 2027 (Art 41(3))
- IA on data for traceability DDL August 2027 (Art 42(7))
- IA on Single European Code (SEC) DDL August 2027 (Art 43(3))
